NB-Air[™] Terms of Use

Updated: December 1, 2022

These NB-AirTM Term of Use (these "Terms") are entered into by and between you and Nucleus Biologics, LLC ("Nucleus Biologics," "we," "our" or "us"), and, together with our Terms of Use and Privacy Policy, govern your access to and use of the NB-AirTM services (the "Services").

If you are using the Services on behalf of a business or legal entity, then you represent and warrant that you have the authority to accept these Terms on behalf of such business or legal entity, and that such business or legal entity accepts these Terms. You also represent and warrant that you are using the Services for a business purpose and not as an end consumer.

Purchase Terms: Your order of products from us may be subject to separate purchase terms and conditions, statements of work, or similar agreements entered into between you and Nucleus Biologics at the time of purchase, which may supplement or supersede these Terms and which may include purchasing requirements applicable to your use of the Services.

<u>User-Provided Formulations</u>: For purposes of these Terms, "User-Provided Formulations" means your cell culture media formulations which you submit, share or send to us through the Services, or that are otherwise received by us from you. We acknowledge and agree that, as between us and you, you own all of your User-Provided Formulations and your User-Provided Formulations are considered your Confidential Information hereunder and we will not use your User-Provided Formulations except to provide the Services. Notwithstanding the foregoing, you understand and acknowledge that we will not take any steps to verify your User-Provided Formulations against any other formulation used, provided by or developed for other customers, nor can we provide you any assurances that another customer of our Services has not, or will not, submit to us similar or the same user formulations as your User-Provided Formulations.

Tool-Assisted Output Formulations: For purposes of these Terms, "Tool-Assisted Output Formulations" means the cell culture media formulation output (whether an incomplete or unused formula output, or any portion, subset or derivative) resulting from use of NB-AirTM that is derived from our algorithms or based on your Provided Formulations. Nucleus Biologics expressly retains all rights that it may have to Tool-Assisted Output Formulations. You understand and agree that we will not take any steps to verify any portion of any Tool-Assisted Output Formulation, nor can we provide you any assurances that any Tool-Assisted Output Formulation has not been, or will not be, provided to another customer of our Services based on such customer's similar user formulations or any freedom to operate. You agree that you will not modify, claim exclusive ownership of, or seek to patent, any Tool-Assisted Output Formulation, then you hereby grant Nucleus Biologics a royalty free, fully-paid up, nonexclusive right and license to any patent you file, sublicensable to any customer, to make, use and sell its product and both Nucleus and the sublicensed customer shall not be liable for any infringement thereof. Access and Use: Subject to and conditioned on your compliance with these Terms and payment in full of all fees hereunder, Nucleus Biologics hereby grants to you a non-exclusive, nontransferable, non-assignable, limited license to use the Services during the Subscription Term solely for use by you and your Authorized Users, as applicable, in accordance with the terms and conditions herein. Such use is limited to your internal business purposes of developing formulations and ordering media products from Nucleus Biologics and not for commercial reuse of the Services or any functionality of the Services or for use as an end consumer.

Authorized Users: You agree that the total number of Authorized Users will not exceed the number of Authorized Users for which you or your organization, as applicable, have purchased a license to the Services, except as expressly agreed to in writing by Nucleus Biologics, and subject to any appropriate adjustment of the Fees payable hereunder.

Confidentiality: Except as set forth herein, the recipient will use the other party's Confidential Information only to exercise its rights and fulfill its obligations under these Terms. The recipient will use reasonable care to protect against the disclosure of the other party's Confidential Information to other parties other than the recipient's employees, affiliates, agents or professional advisors (collectively, "Delegates") who need to know it and who have an obligation to keep it confidential. The recipient will ensure that its Delegates are also subject to the same non-disclosure and use obligations set forth in these Terms. The receiving party may disclose the other party's Written permission.

Fees. You agree to pay all applicable fees for the Services in accordance with the applicable fee and payment terms therefor, as determined by Nucleus Biologics at the time of purchase or subscription, as set forth on the applicable web form, quotation or order form or as otherwise set forth in our Terms of Use, as applicable.

Automatic Renewals:

We may allow you automatically renew the Services at the end of the Subscription Term. If you elect to automatically renew the Services, then we may automatically renew the Service at the end of the current Subscription Term and charge you the then-current price for the renewal term, unless you have chosen to cancel the Service before the end of the current Subscription Term. We will bill your selected payment method for the renewal, whether it was on file on the renewal date or provided later.
